What is this type of insurance?

This is a Professional Indemnity insurance policy.

Statement of Demands & Needs

This product meets the demands and needs of customers who wish to be indemnified against legal defence costs and/or compensation that may become payable to a client following an error or omission in the customer's work that results in the client suffering a financial loss.



What's insured?

- ✓ Any negligent act error or omission of the Insured
- ✓ Any negligent act error or omission of any specialist designers, consultants or sub-contractors of the Insured
- ✓ Dishonest, fraudulent or malicious act or omission of any Employee
- ✓ Libel, slander or defamation
- ✓ Unintentional breach of confidentiality
- ✓ Unintentional infringement of intellectual property rights
- ✓ Loss of or damage to Documents
- ✓ Collateral warranties
- ✓ Data protection defence costs



What's not insured?

- ✗ The Excess
- ✗ Claims and circumstances known at inception of cover
- ✗ Insolvency or bankruptcy of the Insured
- ✗ Trading losses, fines or penalties
- ✗ Claims brought under North American jurisdiction
- ✗ Contractual liability
- ✗ Dishonest, fraudulent, malicious or illegal acts (other than by employees)
- ✗ Claims by financially associated persons or entities
- ✗ War, Terrorism and Nuclear risks
- ✗ Any losses which the insured is entitled to indemnity under any other insurance
- ✗ Any investment or financial advice, or arrangements made by the Insured
- ✗ Claims directly or indirectly involving the combustibility or fire safety requirement of any cladding, glazing, doors, balconies, roofs (incl voids and cavities), external and internal wall systems, and any component or material used in the manufacture, assembly or construction thereof

Are there any restrictions on cover?

- ! Endorsements may apply to your policy. These will be shown in your policy schedule.
- ! This is a claims made policy. The policy will only cover claims that arise and are notified to Qdos during the Period of Insurance.



Where am I covered?

- ✓ Worldwide excluding USA/Canada



What are my obligations?

- At the beginning of the period of insurance or when making changes to your policy, you must give complete and accurate answers to any questions you are asked relating to the insurance.
- You must take reasonable precautions to prevent loss or damage and to comply with all obligations and regulations imposed by any authority.
- You are required to notify Qdos of all material facts and alterations to the risk which come light during the period of cover.
- You must advise Qdos or the Insurer as soon as reasonably practicable of any incident that may give rise to a claim and forward any correspondence you receive in respect of any potential claim without delay.



When and how do I pay?

- Payment can be made online or over the phone with a Qdos representative.
- Payment can be in full or monthly.
- If opting to pay in full, payment is due on or before the policy start date by credit/debit card or bank transfer.
- If opting to pay monthly:
 - o An initial payment is due on or before the start date by credit/debit card or bank transfer. This will represent 1/12th of the policy premium.
 - o The remaining instalments are due by direct debit. Payment can be collected on 7th, 14th, or 21st of the month. A direct debit instruction must be set up within the first month of policy cover, otherwise the policy will be cancelled.
 - o When paying by direct debit, a £23.00 Direct Debit fee will be charged annually alongside the initial instalment.



When does the cover start and end?

- This is an annual policy; the start date can be selected during your application.
- The start date can be today, or any date within the 30 days following your application. The policy cannot be backdated.
- The period of insurance will be specified in your policy schedule.



How do I cancel the contract?

- You can cancel this insurance at any time by contacting Qdos.
 - If you cancel within the first 14 days, you will be entitled to a full refund.
 - If you cancel after the above, you will be entitled to a pro-rata refund after the deduction of a £20.00 cancellation fee.
 - No refund will be provided if you cancel the policy after the insurer has paid a claim.
